

## **Brown Wrestling Tallies Seven Place-Winners in Season Debut at Bearcat Open**

VESTAL, N.Y. – Senior **Justin Staudenmayer** finished second at 157 lbs. to lead a group of seven place-winners for Brown University wrestling in its season debut at the Jonathan Kaloust Bearcat Open at the Events Center on the campus of Binghamton University on Sunday.

In addition to their seven place-winners, the Bears advanced 11 wrestlers to the quarterfinals and totaled 12 student-athletes who registered two or more wins. Brown collected five falls as a team on the day.

Staudenmayer (Plymouth Meeting, Pa.) won four straight bouts to advance to the first-place match at 157 lbs. while senior **Zeke Salvo** (Baltimore, Md.) claimed back-to-back wins to reach the semifinals before eventually capturing the third-place match at 133 lbs.

Juniors **Jon Viruet** (Springfield, Mass.) and **Ian Butterbrodt** (North Andover, Mass.) both placed fifth at 165 lbs. and 285 lbs. respectively. Each wrestler compiled five victories at the tournament.

Freshman **AJ Pedro** (Methuen, Mass.) came in sixth place at 184 lbs., winning twice to reach the quarterfinals before taking two wins in the consolation bracket. Junior **Andrew LaBrie** (Exeter, R.I.) and sophomore **Trey Keeley** (Washington, Ill.) each tied for seventh place at 174 lbs. and 125 lbs. respectively.

Freshman **Hunter Kosco** (Canal Fulton, Ohio) won three times at 133 lbs., while junior **Tucker Ziegler** (Myersville, Md.) and sophomores **Jimmy Pawelski** (Park Ridge, Ill.), **Zach Krause** (Plainfield, Ill.), and **Matt Lattanze** (Norristown, Pa.) each picked up two wins.

Salvo, Pawelski, Krause, LaBrie, and freshman **Bryce Rogers** (Orlando, Fla.) posted one fall apiece.

Next, Brown will compete at the Navy Classic on Saturday, November 18 in Annapolis, Md.
