

The Charger JV crew got their first competition on Saturday as well as they faced the same teams on the JV side of the tournament. Attached are the results.

132 - Axel Stenberg (2-1, 3rd Place). Axel opened with the overall Champion in Cole Ackerman of Sauk Rapids Rice. He had a bye in the opening round of wrestlebacks and then picked up a fall over a Waconia wrestler and a fall over a Forest Lake wrestler to take 3rd place.

138 - Brandon Hackbarth (0-3, 4th Place). Brandon lost his opening round match to a Waconia wrestler. His second round was against a St. Cloud Tech wrestlers and his last round against a Forest Lake wrestler.

152 - Cade Anderson (1-1, 2nd Place). Cade had an opening round bye followed by a 3rd period pin over a Forest Lake wrestler to make the final. His dropped his last match to a different Forest Lake wrestler.

152 - Austin Campbell (1-1, 2nd Place). Austin dropped his opening match to a Forest Lake wrestler, but bounced back and picked up a fall against a wrestler from STMA

195 - Jace Butcher (1-3, 6th Place) - Jace was behind in his opening round match against a Forest Lake wrestler, but picked up a fall with a headlock as time was running out in the 3rd period. He lost his semi-finals match to a Robbinsdale Cooper wrestler followed by a decision loss to teammate Devan Campbell in the wrestleback semifinals. Jace lost by fall in his last match to a Forest Lake wrestler.

195 - Devan Campbell (3-1, 3rd Place) - Devan dropped his opening round match a Waconia wrestler. He picked up three straight wins in the wrestlebacks over a Perham wrestler, teammate Jace Butcher, and the same Waconia wrestler that beat him in the first round.
