#10 Minnesota State Closes Out Regular Season With 18-16 Win at MSU-Moorhead

Moorhead, Minn. --- #10 Minnesota State completed its 2018-19 regular-season schedule by earning an 18-16 road Northern Sun Intercollegiate Conference dual at MSU-Moorhead Sunday.

The Mavericks won five of ten matches vs. the Dragons in upping their record to 9-2 on the season. Minnesota State finished second in the NSIC with a 7-1 mark against conference opponents.

Minnesota State senior **George Farmah**, who is rated #7 at 133, upped his record for the year to 8-2 with a 7-3 decision over Seth Huchison. Sophomore **Kyle Rathman** entered the weekend rated second in the country at 149 and stands 13-2 on the year after picking up a 10-2 decision over Dylan Connell. Junior **Zach Johnston**, who is rated #4 at 174, stands 11-4 on the season after picking up a 3-1 win over Adam Blee. Junior **Logan Saltou** stands 15-6 this season after earning a 14-3 major decision over Justin Davis and freshman **Trevor Turriff** picked up a 19-9 major decision over Evan Foster at 184 and stands 12-4 for 2018-19.

Next action for Minnesota State is Feb. 23 when it competes at the NCAA Division II Super Regional at Moorhead, Minn.

#10 Minnesota State Falls at #1 St. Cloud State Saturday

St. Cloud, Minn. --- #10 Minnesota State took on #1 St. Cloud State in a Northern Sun Intercollegiate Conference dual in St. Cloud Saturday and it was the host Huskies that came away with the victory.

The loss, in which Minnesota State won two of ten matches, brings the Mavericks' record to 8-2 on the season and gives them a 6-1 mark in NSIC contests.

The Huskies upped their record to 19-0 with the win over the Mavericks.

The Huskies won the first three matches of the dual before Maverick senior **George Farmah** claimed a 1-0 decision over Garrett Vos at 133. Junior **Logan Saltou** also picked up a medical forfeit victory at 165.

Next action for Minnesota State is tomorrow with a road dual at MSU-Moorhead slated.
