EAST STROUDSBURG, Pa. - The East Stroudsburg University men's wrestling team lost 35-12 to No. 14 Gannon Friday night in Koehler Fieldhouse.

Notables

[Sean Campbell](#), who wrestled in one of two extra matches, started the Warriors' night on a positive note by defeating his opponent by decision. Campbell entered the final period up 7-6 and kept his opponent at bay to claim the victory.

[Austin Noe](#) picked up the first points for ESU late in the second period. Up 10-3, Noe managed to turn his opponent one last time to win by pin.
